The case has been examined by Fire Officer on the basis of photographs of the building/system mentioned above viz-a-viz approved Fire Fighting Scheme, National Building Code 2016 Part-IV and the Haryana Fire and Emergency Services Act, 2022. After examination, it is recommended that Fire Safety Certificate may be issued subject to the following conditions:-

- The owner/occupier shall appoint duly trained Fire Safety Officer along with Fire Staff round the clock in building.
- ii. All the firefighting equipments shall be maintained in perfect working condition every time. If any lapse is found in the fire protection system at the time of inspection or noticed during outbreak of fire, action will be taken against owner/occupier as per the provision of Haryana Fire and Emergency Services Act, 2022 and rules.
- III. The owner/occupier shall apply for Renewal Fire Safety Certificate 2 month prior to expiry of this Fire Safety Certificate on www.Saralharyana.gov.in portal.
- iv. The open set back area is not checked by Inspecting team of Fire Station and the same shall be checked by concerned building authority/department.
- v. The owner/occupier shall strictly follow all other applicable rules/regulations/byelaws laid down regarding fire safety system. If owner/occupier fall to comply with any of the above terms & conditions, he will be liable to be punished as per Section 30,31 & 47 of Haryana Fire & Emergency Services Act 2022.
- vi. The owner/occupier shall perform quarterly Fire Drill in his building as per provision of National Building Code under intimation to Fire Department and videography evidence to be kept as a record which shall be produced at the time of next Renewal of Fire Safety Certificate. The Residents/R.W.A. shall be involved in the said Fire drill.
- vii. If the Infringements of Byelaws remains un-noticed, the Authority reserves the right to amend the Fire Safety Certificate as and when any such Infringements comes to notice after giving an opportunity of being heard and the Authority shall stand Indemnified against any daim on this account.

- viii. The owner/occupier shall submit a self-declaration certificate every year to the effect that the firefighting system installed in his building is in good working condition and there is no addition/alteration in the building. The Fire Official may randomly check such building.
- In case there is any addition/alteration beyond permissible limit under the Haryana Building Code, 2017, the Fire Safety Certificate shall seized to exist and the owner shall apply for approval of revised Fire Fighting Scheme as per the section 18 of Haryana fire & Emergency service Act, 2022.
- x. Any deviation with regard to construction, ventilation, occupation, Electrical Installation etc. may be got verified from the concerned authorities. In case of deviation the fire safety certificate shall be treated as Null & Void.
- xi. The fire safety certificate shall never be treated for the purpose of regularization of unauthorized construction.
- three years for other than residential buildings (A1 to A4) from the date of issuance of this certificate in accordance with sub section 4 of section 19 unless renewed under section 20 or sooner cancelled under section 21 of Haryana fire & emergency service Act, 2022.

It is mentioned here that approval of firefighting scheme already stands approved vide letter No. FS/2023/923 dated 18.08.2023 and the building is Government Building and verified by Tehsildar, Jhajjar (Haryana).
